Privacy Policy

1. General Information

This Privacy Policy explains how EDUCATRADER LTD (Company No. 15668675)

("Company"; "we"; "us"; or "our") collects, uses, and protects your personal information when you visit our website or purchase our educational packages, courses, or other services.

We are the Data Controller for all personal data processed through this website under the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

By using our website, you agree to this Policy. If you do not agree, please discontinue use of our site and/or products.

2. What Data We Collect

We collect only the information necessary to deliver our services effectively. This may include:

Category	Examples
Identity Data	Full name, username
Contact Data	Email address, phone number, billing address
Payment Data	Transaction references via secure third-party processors (we do not store card details)
Account Data	Login credentials, access logs, settings
Technical Data	IP address, browser type, device information
Usage Data	Pages visited, time spent, navigation paths
Marketing Preference	Newsletter opt-ins or opt-outs

We do not collect sensitive personal data (such as health, political, or biometric data).

3. How We Use Your Data

We process personal data only where lawful and necessary, including:

- To register you as a customer and manage your account;
- To process and deliver your purchases;
- To provide support and respond to enquiries;
- To send important service or security updates;
- To improve our website and learning experience;
- To send optional marketing messages (with your consent);



To comply with legal and tax requirements.

4. Legal Bases for Processing

We rely on the following lawful bases under UK GDPR:

- Performance of a contract to provide you with the purchased service;
- Consent for marketing or newsletter communications;
- Legal obligation to meet tax or record-keeping requirements;
- Legitimate interest to improve services, prevent fraud, and ensure security.

5. Sharing and Disclosure

We never sell or rent your personal data.

We may share limited information with trusted third parties strictly for operational purposes, such as:

- Payment processors;
- Website hosting and IT security providers;
- Email or CRM platforms (for support and updates);
- Professional advisers (legal, accounting);
- Law enforcement or regulators when required by law.

All third parties are bound by contract to handle data securely and comply with UK GDPR. When it is necessary for us to transfer your personal information outside of the UK this will only be done in accordance with the UK GDPR.

6. Data Retention

We retain your data only as long as necessary for the purposes set out in this Policy:

- Customer and purchase records up to 7 years (for tax and accounting purposes);
- Marketing data until you withdraw consent;
- Technical logs typically 12 months or less.

Data is securely deleted or anonymised once no longer needed.

7. Your Rights Under UK GDPR

You have the following rights over your personal data:

- a) Access request a copy of your data;
- b) Rectification correct inaccurate information;



- c) Erasure request deletion ("right to be forgotten");
- d) Restriction limit processing;
- e) Portability receive data in machine-readable form;
- f) Objection to processing based on legitimate interest or marketing;
- g) Withdraw consent for any processing based on consent.

We may require identity verification before acting on your request.
